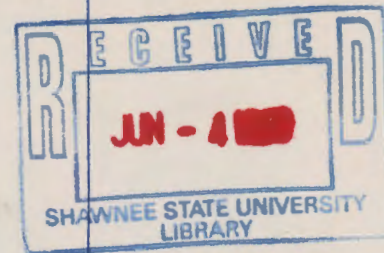

New Beginnings

Which buildings are the focal points of a college campus? Which convey that air of significance, import and consequence that defines the university as being part of academe? Which serve as hallmarks — announcing that this institution takes education seriously, that it acts on the commitment to nourish the student's intellect by fostering the lifelong love of thoughtful investigation that will prepare them for the future?

Surely one of the structures that best defines the character of a university is its library. At Shawnee State, we have been without a freestanding library, but within the month, our new building will open its doors to the public. We will begin moving the collection on June 7, and the Massie Hall facility will close on June 13. The new Library, so long awaited, is scheduled to open on June 20.

Some of the things you can expect to see in the Library are:

- A 68,838 square foot facility full-carpeted for enhanced comfort and reduced noise levels.
- Greater accessibility for users with special needs, including ramps to all raised areas, airport-style rostrums, furnishings, phones, and drinking fountains with proper heights for wheelchairs.
- A mixture of old and new furnishings until all tables, chairs, and service counters arrive in July.
- A 338-seat subdividable lecture hall, which will encourage use of the Library.
- Ten group study rooms for those needing to discuss projects.
- Improved access to materials due to more filing and shelving space.
- Better photocopying facilities.
- A Curriculum Materials Center for housing educational materials.
- Shelved current periodicals located in soft seating areas for leisurely reading.
- Two classrooms with media projection capabilities.
- Seating for 600 in study seats, carrels, tables, and soft chairs.
- A shelving capacity of 145,000 volumes. We now own 100,000 volumes.
- Relocation of Media Services, making material reservations even more imperative.
- Reduced hours of operation. Due to a doubling of service points for the same amount of staff.

We realize our moving will be an inconvenience to the university community, but we ask that you bear with us as Shawnee State makes another exciting transition within the ranks of Ohio's excellent universities.
