PRESIDENT'S REPORT

Dr. Flinchbaugh reported that the State Department of Education, Division of Vocational Education visited Shawnee State's campus for a follow-up of last year's technical education review. They gave the technical programs an exemplary evaluation, commenting that Shawnee has some of the finest programs in the state. They also gave the counselors a very high rating. The North Central Evaluation Self-Study Committee will have its final meeting on Wednesday February 21. There has been much input from the college community for this report. It will go to the printers and then be mailed to members of the Evaluation team who will be on campus for an on-site visit beginning May 7 for two or three days.

A student who graduated in the Business Technologies Program in Accounting has passed the state test for C.P.A.

The first meeting of the Presidential Advisory Committee will meet on Friday February 23. Also the second meeting of the monthly faculty/administrators meeting will be held Tuesday, February 20.

Pr. Flinchbaugh asked Mr. Taylor to report on the new facilities. March 9, "B" building will be ready for the Mexican Folk Ballet. Mr. Taylor has sent letters of intent to the low bidders on the new T & I building which should begin in about 30 days. Money for the nursing wing addition has been put into the T & I building. A Pinkerton guard has been hired for security at night and the guard is on duty from 5:30 - 10:30 each evening. The guard is not armed at this time.

RESOLUTION 5-79

Whereas it is the intention of the Board of Trustees to permit the use of College facilities for certain type of religious meetings and conferences, and

Whereas it is the Board's intention to not permit religious organizations to use the facilities for religious ceremonies or worship services that are held on a regular basis, and

Whereas it is the Board's intention to give the administration some latitude in making decisions about the use of the facilities for religious purposes;

Now, therefore, be it resolved that the Board of Trustees of Shawnee

State Community College hereby approves a revision to Section 10.100 Community

Use of College Facilities, said revision involving deletion of the sentence

"The College facilities shall not be available to any religious organization
which intends to hold religious meetings."

CHAPTER 10

BUILDINGS AND GROUNDS

10.100 Community Use of College Facilities

Shawnee State Community College, being a state assisted institution of higher education which is community oriented in its service capacity, encourages use of its facilities by community organizations and groups during those times when such use will not interfere with the regular educational program or other bona fide college activities. College facilities may not be reserved for parties or celebrations such as anniversary or birthday parties that are of a private nature.

The College assumes no responsibility for the views expressed by organizations or groups using the College's facilities, nor do the organizations or groups have any endorsement from the Board of Trustees for their views or opinions.

The College President is authorized to publish procedural guidelines implementing or altering those procedures stated within this policy as originally adopted in order to provide for the safety of participants, protections of the College facilities and equipment, and applicable reimbursement.

There is nothing explicit or implicit in this policy which guarantees any tax exempt or profit making organization the right to use the College facilities or equipment. The College will review each application and make a determination accordingly whether or not an organization will be granted the privilege to use facilities or equipment.

RESOLUTION 6-79

Be it resolved by the Board of Trustees of Shawnee State Community College that the Board hereby approves the 1979-80 College calendar as attached to this resolution, and

Be it further resolved that the College will hold ceremonies on President's Day and Martin Luther King Day to recognize these leaders.

RESOLUTION 7-79

Whereas Shawnee State Community College's administration informally discussed a scholarship program with the Board of Trustees in early 1977, and,

Whereas as the Board approved Budgets for 1977-78 and 1978-79 which included monies for such scholarship program, and,

Whereas in 1977-78 and 1978-79 Shawnee State Community College awarded qualified high school graduates a scholarship for attending Shawnee State Community College, and

Whereas as the State Auditor's office - University Audit Division has questioned the funding source (General Fund) for such a program, and

Whereas formal Board action addressed specifically to the scholarship program would show the intent of the Board concerning the matter of such expenditures;

Now, therefore, be it resolved that the Board of Trustees of Shawnee State Community College does hereby support and approve said scholarship program as being most beneficial to the College and the people it serves, and concurs with the continuance of the program in it's entirety.

RESOLUTION 8-79

Whereas, Shawnee State Community College has been fortunate to have many years of encouragement and support from its State Representative,

The Honorable Vernal G. Riffe, Jr., Speaker of the Ohio House of Representatives, and

Whereas, Representative Riffe has been instrumental in the successful creation of Shawnee State Community College;

Now therefore be it resolved that the Board of Trustees of Shawnee State Community College thanks Mr. Riffe for his generous encouragement and support, and

Be it further resolved that the Board does hereby act to name the new Industrial Building the "Vernal G. Riffe Industrial Building" as a "thank you" to Mr. Riffe and as an attempt to reflect his contributions over the years to the people of the area now and in the future.

RESOLUTION 9-79

Whereas, a salary program has been developed for administrators, program directors, faculty, and support staff (should Civil Service be terminated at Shawnee State Community College by a court decision), and

Whereas, the Shawnee Education Association has agreed to support the salary program and to consider the negotiations in the area of salary prebargained for school years 1979/1980/1981, and

Whereas, all full time employees have had opportunities to voice their opinions about the salary program, and

Whereas, full time faculty, administrators, program directors, and support staff voted to agree with and support the proposed salary program on March 19, 1979, and

Whereas the Board of Trustees has met with representatives of the administration, faculty, and support staff on several occasions and the Finance Committee of the Board has met with representatives from these groups a number of times;

Now, therefore be it resolved that the Board of Trustees of Shawnee State Community College hereby approves a salary program based on a profit-sharing concept, said approval to be for a period of 2 years, and

Further, that the salary program shall include all full-time faculty (full time faculty inclusion in the system will be subject to the terms of any present or future contract negotiated between the Shawnee Education Association and Shawnee State Community College), administrators, program directors, and support staff (should they be removed from Civil Service by a court decision), and

Further, that the salary program shall be incorporated into the appropriate section of the Policy and Procedures Manual as College Policy, and

Further, that during the trial period of 2 years in: which the salary program is implemented and tested, the Board authorizes the President to work with faculty, administrators, program directors, support staff, and the Board to correct or modify any provisions of the program that are causing problems due to unanticipated variables, inconsistencies, or interpretations.
