RESOLUTION 21-79

Whereas, dental hygiene, respiratory therapy, and radiologic technology are four quarter health programs requiring full time teaching faculty to teach full time each of four quarters, and

Whereas, the practical nursing program is a three quarter plus five week program requiring full time teaching faculty to teach full time each of three quarters and full time for five weeks during the Summer Quarter, and

Whereas, these four health programs are the only curricular areas of the College requiring full time faculty to teach full time during four quarters of a year, and

Whereas, the requirements of state and national organizations as well as the College curriculum requires that these programs operate four quarters a year;

Now, therefore, be it resolved by the Board of Trustees of Shawnee State Community College that the full time teaching faculty in dental hygiene, respiratory therapy, and radiologic technology are granted full time teaching contracts for Summer Quarter 1979 at a prorated salary of their 1978-79 salaries, and

Be it further resolved that the full time practical nursing faculty noted below are granted full time teaching contracts for the first five weeks of Summer Quarter 1979 at a prorated salary of their 1978-79 salaries divided by two (2) since they work one half of Summer Quarter:

RESOLUTION 22-79

Whereas, the present full time faculty member in radiologic technology has resigned her position effective the end of Summer Quarter 1979,

Now, therefore, be it resolved that the Board of Trustees of Shawnee State Community College hereby approves a one year twelve (12) month full time teaching contract for Mr. John Kennedy as Instructor-Clinical Coordinator in Radiologic Technology, said contract beginning September 1979 and continuing through August 1970, and

Be it further resolved that the twelve month contract shall incorporate 15 days sick leave accumulation but no vacation accumulation, and

Be it further resolved the initial yearly salary of \$14,040 for this contract is computed at the 1978-79 rate that will be adjusted accordingly under the new system yet to be determined through negotiations.

RESOLUTION 23-79

Whereas the current bonding policy covers the Treasurer for only \$10,000 and,

Whereas, the bond should be for at least the amount in the Treasurer's control at any given time, and

Whereas the Treasurer has more than \$500,000 invested throughout the year, and

Whereas deposits into the bank are sometimes more than \$100,000;

Therefore, be it resolved that the Board of Trustees of Shawnee State Community College approves the purchase of a bonding policy for the Treasurer in the amount of \$500,000.

RESOLUTION 24-79

Whereas, an operating reserve of College funds is necessary for maintaining a stable financial support for the College in a time of crisis or on an emergency basis;

Now, therefore, be it resolved that the Board of Trustees of Shawnee State Community College hereby declares that the College's reserve funds are to henceforth be used only for emergency purposes or non-reoccurring. expenditures.
