MINUTES

SHAWNEE STATE COMMUNITY COLLEGE Board of Trustees Meeting Monday, August 17, 1981

The meeting was called to order by Chairman Brown.

PRESIDENT'S REPORT

Mr. Foti, Dean of Technical Programs, commented on the excellent report received from the North East Regional Board of Dental Examiners, noting the comparison of the results of Shawnee State dental students with students from other institutions. The students from Shawnee state compared favorably with other students on the comprehensive part of the test, and were above the mean score on the clinical part of the test. Only one student out of the 22 Shawnee State students failed their state board test.

Ms. Dottie Welch, Registrar, gave a report on transcript requests during the 80-81 academic year, noting colleges that students have requested transcripts sent to for transfer purposes.

Copies of the applications for requests of funding from the Pixley Trust, administered by the Scioto Area Foundation, were given the Board members. After some discussion it was decided that the Board members would peruse these applications and give their comments or suggestions by phone to Mr. Taylor. The applications must be submitted to the Foundation by September 1, 1981.

Mr. Taylor continued his report with comments on a meeting held by Governor Rhodes on August 12, with two year college presidents. Mr. Rhodes indicated that there was a need for 1 billion 200 million dollars to keep the educational programs in Ohio at a level that is acceptable. Mr. Rhodes will go to the legislature on September 8 to outline his recommendations for tax increase to aid education in Ohio and he enlisted the aid of the presidents to exert pressure on legislators to pass such legislation as recommended by the Governor.

The Capital Improvement Bill has passed the House. However, the Senate refuses to act on this bill until the one year budget has been adopted. The temporary budget runs through October 31, 1981. The possibility of capital improvements money is unlikely for several months. This is very disappointing to Shawnee State due to the need of parking lot improvement and equipment needs, especially in the technical programs.

Dr. Come reported the the Board members that the Corrections Program is being phased out at the college. The reason for this being low enrollment in the program. The second year of this program will be continued until those in the program have had an opportunity to complete their degree, but no freshman will be accepted into this program. Reason given for this low enrollment is that the State does not give an incentive to employees in correctional institutions if they have completed a degree. Faculty members in this area will be utilized in other areas of teaching and students that want to complete a four year degree in corrections can still attend Shawnee State for two years by concentrating on a liberal arts program that will transfer to a four year institution.

Mr. Taylor commented on the success of the Shawnee State tennis team, coached by Jack Lemaster. The were undefeated in the 8 games that they were scheduled to play.

On July 5, the Community Concert Series had arranged to use the Activities Center in case of rain for a summer concert. The concert was moved to the campus due to rain, and along with the concert the other activities that were scheduled for that day in the Bonneyfiddle area also moved to the campus. The problem with this was that they were not authorized to do this and that they brought with them alcoholic beverages. Alcoholic beverages on campus is against college policy. In anticipation of trouble in the future a letter was sent to the people responsible for the infraction of college policy.

COMMITTEE REPORTS

Education Policy Committe - No report.

Buildings and Grounds Committee - Dr. Carson reported that Mr. Taylor, two members from the architects firm and himself went to Dallas to look at college installations to get ideas for Shawnee State. He indicated that they had some very good ideas but that since the Capital Improvements monies are not yet available no action can be taken on any recommendations offered by this committee.

Mr. Howard continued his report on off-campus offerings by telling the Board that Shawnee State's administrators are talking with the officials of the joint vocational school in Lawrence County about offering classes in Lawrence County. This will probably not happen until next summer.
