## M I N U T E S SHAWNEE STATE COMMUNITY COLLEGE December 16, 1985

The meeting was called to order by Chairman Morgan.

### ROLL CALL

#### APPROVAL OF MINUTES

Mr. Ferguson moved and Mr. Rittenour seconded a motion to approve the minutes of the November 18, 1985 meeting of the Board of Trustees and to approve Resolution 33-85 (telephone vote).

### PRESIDENT'S REPORT

Mr. Taylor stated that he had talked with Mr. Riffe last Monday, (December 9, 1985) and Mr. Riffe informed him that cost figures are needed by January 15, 1986 to construct and equip facilities for the four year institution. The money required will be 35 to 40 million dollars and must be budgeted in the next biennium. It may take as many as three bienniums to get the necessary funds. Mr. Taylor stated that Shawnee State should first complete a curriculum study which, in turn would determine what facilities, etc. would be necessary. However, because of all the constraints we will have to work backwards. Mr. Taylor and Mr. Riffe discussed the fact that help would be needed from architects and their general feeling was that local architects should be used. Hayes, Tanner and Associates and Gerald P. Pierron, Architect, have been contacted and they have agreed to work with the college to give information on architectural needs. Mr. Hayes will be the main architect and Mr. Pierron and Mr. Joe Barany will be consultants. Mr. Barany helped design the present campus facilities.

The State Architect's will choose three architectural firms to design the new facilites and the Board of Trustees will make the decision on which architectural firm will be hired for the job. It is hoped that the local firms will be on the list of three. Both Mr. Riffe and Mr. Taylor prefer the work to be done locally.

Dr. Carson asked what buildings the facilities committee were recommending at this time. Some suggestions are: library, bookstore, print shop, learning center and a performing arts center, with seating for 3000 people. The performing arts center could be in the first or second biennium. Also, some people have suggested a child care facility and a new food service area with banquet facilites. Land acquisition will also be a part of the need for the new university. The question concerning appropriation of monies for the second phase of the feasibility study was asked. Mr. Taylor stated that this money will be forth-coming but he has no time frame for the appropriation at this time.

Mr. Brown moved and Mrs. Andrews seconded a motion for Mr. Taylor to proceed with plans for the new university and to use the local architects to help formulate these plans.

Mr. Taylor asked Mr. Foti to report on test scores for Medical Laboratory, Radiology, and Licensed Practical Nursing, three allied health programs whose students graduated in July, 1985. All eighteen graduates in the Medical Lab Program passed the National Tests. Three students scored over 90%, which represents the top 1% of all examinees.

All eleven graduates in the Radiologic Technology Program passed the Registry Test. Two of the graduates scored in the nineties. Shawnee's average score was 82, as compared with the national average of 81.76. Six of the graduates already have full or part time jobs and one student is taking advanced classes.

Nineteen candidates took the State Board Exam for Licensed Practical Nurses Program. All nineteen passed the exam. The mean score was 655, compared to last year's mean scale which was 617. This is the eighth consecutive year that all PN candidates have passed the exam. Two students passed with scores of 800, this may be a perfect score. Shawnee State's Practical Nursing Programs ranks in the top five in the State of Ohio.

Most of the students in these programs have been placed or are pursuing advanced degrees.

Another plus for Allied Health Programs is the awarding of five year accrediation of the Occupational Therapy Program. The new program for Physical Therapy will begin in Fall, 1986.

NEW BUSINESS

Mr. Morgan appointed a nominating committee for selections of new officers for the Board of Trustees for 1986:

Mr. Ferguson moved resolution 35-85 be approved, hiring of Dr. Sandra Kay Lewis, as Director of the Physical Therapy Program, which was approved by the Ohio Board of Regents a year and a half ago, but which to date has not been started due to the lack of a Director. The motion was seconded by Mr. Rittenour.
