# RATIFICATION OF COLLECTIVE BARGAINING AGREEMENT COMMUNICATION WORKERS OF AMERICA

WHEREAS, the agreement between Shawnee State University (University) and the Communication Workers of America (CWA) expired November 6, 1998; and

WHEREAS, a tentative agreement between the University and CWA has been reached; and

WHEREAS, the CWA membership approved the agreement; and

WHEREAS, such agreement is binding on the University and the CWA effective November 7, 1998 until midnight November 6, 2001; and

WHEREAS, the agreement is recommended by the University's chief negotiator and the President for ratification; and
