EXECUTIVE COMMITTEE REPORT July 11, 2000

Meeting was called to order by the Chairman at 4:03 p.m.

1.0 Minutes and Certification of compliance with RC 121.22(F)

The Secretary confirmed compliance with RC 121.22(F). Mr. Davis moved and Mr. Harcha seconded approval of the minutes from the 5/9/00 meeting of the Committee. Without discussion the Committee unanimously approved the minutes.

2.0 Approval of Job Prep Workforce (JOBS) Grant, Title III Grant, and 21st Century Learning Centers Action

The President briefed the Committee that the JOBS program received notification that the Scioto County Department of Human Services grant in the amount of \$141,683 for the period 7/1/00-12/31/00 has been approved. This grant will be used to support the Ohio Works First program by providing employment readiness, job-seeking skills to OWF clients as well as student retention services. This is a grant for the operation of JOBS under the direction of Ms. Shelpman which will be phased out after 12/31/00.

The President briefed the Committee on the Title III grant will provide for \$1,620,701 over five years to help Shawnee improve student retention through basic skills curriculum revision, student support services, and faculty/staff development. Dr. Chapman noted it was very difficult to obtain this grant the first time it is applied for, but SSU was successful thanks to the help of Maysville Community College, and Dr. Field who was instrumental in leading this effort. Dr. Field noted that this was big news. He felt there was only one in twenty-five chance of SSU being approved for this grant. The grant normally takes six months to write and SSU wrote it in two months. Cathy Mullins and Tim Culver worked on getting this grant for SSU. Dr. Field said this grant will work as a change agent for the University. In response to Mr. Harcha's question about how the faculty will help with retention, Dr. Field said a coordinating committee of faculty helped to write important pieces of this grant. He did not think there would be any problem in engaging faculty to help in student retention.

The President also briefed the Committee about the University Outreach Services which received notification that the U.S. Department of Education had approved a 21st Century Community Learning Centers Expansion Grant to Scioto County Joint Vocational School as fiscal agent. The SCJVS will subcontract with SSU to provide tutors for school children after normal school hours to help them pass state proficiency tests in reading, mathematics and science. This program will be managed through Ms. Ramey.

Ms. Argeros moved and Mr. Harcha seconded **Resolution E10-00**, accepting these grants. Without further discussion the Committee unanimously approved Resolution E10-00.

3.0 Approval of New Positions for 21st Century Learning Centers Action

The President advised the Committee that with the approval of the 21st Century Learning Centers grant to SCJVS, by Resolution E10-00, the University should establish four positions, funded by the grant, to implement the tutoring program. These new positions will be continuous temporary contracts, since the funding is temporary. The positions which the University would like to establish are: Manager, 21st Century Learning Community; Scioto County Coordinator, 21st Century Learning Community; and Lawrence County Coordinator, 21st Century Learning Community. Mr. Harcha moved and Mr. Davis seconded **Resolution E11-00**, establishing the positions. Without further discussion the Committee unanimously approved Resolution E11-00.

4.0 Personnel Appointments

Action

The President briefed the Committee that the University hired two new faculty members one in the Department of Arts and Humanities for teaching graphic design and the other in the Department of Teacher Education for the Sports Management program. The President recommended the Committee approve their hire. Mr. Harcha moved and Mr. Davis seconded **Resolution E12-00** approving these new hires. Without further discussion the Committee unanimously approved Resolution E12-00.

In response to Dr. Payne's questions regarding recently passed legislation, Dr. Chapman noted that Senate Bill 53 now permits public universities in Ohio to charge in-state tuition rates and receive subsidies for residents of contiguous states who are employed in Ohio and whose employers contract to pay their tuition and fees. Senate Bill 210 clarifies the authority of boards of trustees over decision-making related to employees of state universities, and eliminates the requirement to draft classification plans for unclassified employees.

Dr. Chapman read a thank you letter from Mr. Gary Gemmer, President of SEA, which said:

The recent revision of the workload policy was an extraordinary good faith gesture by the Board. I have heard nothing but positive feedback from the faculty. Thanks to all.

The meeting adjourned at 4:19 p.m.

PURPOSE: To provide assessment, employment readiness, job-seeking skills training, short-term training, and associate and baccalaureate student retention services to underprepared students from July 1, 2000 through December 31, 2000.

CLIENTELE TO BE SERVED: Ohio Works First participants residing in Scioto County.

RELATIONSHIP TO SSU MISSION: To motivate and encourage regional students to attain workforce skills, to attend college and to gain self-sufficiency.

OTHER AGENCIES/ORGANIZATIONS PARTICIPATING IN PROJECT: Ohio Board of Regents; LMUS Community Gifts.

BRIEF DESCRIPTION OF HOW PROJECT WILL BE CONDUCTED:

Participants will be provided a two-day comprehensive assessment and two-week employment readiness training including a computer literacy component. Individual cases will be reviewed and additional activities will be recommended and provided, such as short-term training or enrollment into an associate or baccalaureate degree program. Student retention services will include the Connection Library for text loans, scholarships, educational equipment rentals, and other educational needs such as uniforms, engineering kits, etc.

Students attending schools participating in the 21st Century Community Learning Centers.

RELATONSHIP TO SSU MISSION:

Pledge to developing cooperative relationship. Shawnee State University is, therefore, a willing partner in cooperative ventures with educational institutions and organizations that assist in developing the economic, educational and cultural and of South Central Ohio

Shawnee State University and area school districts will establish a partnership to create "21st Century Community Learning Centers." The Centers will be established to enable the school to provide significant expanded learning opportunities for children and youth in their communities to assist students to meet or exceed state and local standards in core academic subjects including reading, mathematics, and science.

OTHER AGENCIES/ORGANIZATONS PARTICIPATING IN THE PROJECT:

Local agencies and businesses will also partner with participating school districts to provide educational programming in the "after school" centers.

BRIEF DESCRIPTION OF HOW PROJECT WILL BE CONDUCTED:

Shawnee State University will coordinate services for Tech Prep consortium member schools. Funds for coordination will be accessed through the Scioto County JVS, the fiscal agent for the project. Selected university student employees will provide tutoring services at selected centers.

TITLE: Title III - Strengthening Institutions

GRANTING AGENCY: U.S. Department of Education

PRINCIPAL INVESTIGATOR: Cathy Mullins, Associate Director, Outreach Services, Grants Mgt. PERCENTAGE OF P.I. TIME DEVOTED TO GRANT: 20%

PURPOSE: Title III programs are designed to assist eligible institutions of higher education to increase their self-sufficiency by providing funds to improve academic quality, institutional management, and fiscal stability

CLIENTELE TO BE SERVED: Shawnee State University students, especially those who need learning assistance during their college careers.

RELATIONSHIP TO SSU MISSION: Title III funding will assist the University in its commitment to "...providing an undergraduate education that fosters competence..." The focus of the proposal is the improvement of Shawnee State University's ability to identify and serve students who may have academic deficiencies and other educational needs that may prevent them from eventual graduation from the University.

OTHER AGENCIES/ORGANIZATIONS PARTICIPATING IN THE PROJECT: None

BRIEF DESCRIPTION OF HOW PROJECT WILL BE CONDUCTED:

Over a five-year period, various components of a coordinated and coherent system of student services will be implemented. Components may include:

- A nationally normed and validated diagnostic evaluation system designed to more adequately address individual learning needs.
- A centralized advising system, where students may seek and obtain the information
 and counsel they need in one stop, assisting them not only in determining the next
 term's schedule, but in considering career options and finding solutions to personal
 challenges as well.
- Implementation of an individualized, self-paced, program of developmental
 education that includes computer-aided instruction and may include the addition of
 developmental science courses, study skills and student survival skills. Planning also
 includes specialized computer laboratories to serve the developmental needs of our
 students.
- Improved methods of identifying students with developmental needs and implementation of a proactive system to track their progress and continue to serve their needs throughout their college careers.
- Assistance and release time for faculty in learning to use the new assessment tool
 and to integrate it into the curriculum and to transition to a more centralized
 approach to advisement thus, better serving our students' developmental needs.
